

## **Terms and Conditions of the contest “#myChristmasRecipe2014”**

\*This promotion is not sponsored, endorsed or administered by, or associated with, Facebook and / or Instagram.

1. Organization: The company organizing this promotion is ONLY-APARTMENTS, SA, Av. Drassanes 6-8, pl 15, 08001 Barcelona, CIF: A64425986

2. Participation: The participation of this contest occurs over the social network Instagram. In order to participate it is required to be an Instagram user and follow onlyapartments on Instagram. To be eligible, participants must be of legal age. Employees of Only-apartments and their direct family cannot participate.

3. Promotion details and prizes: To enter in the drawing, Instagram users must upload up to 3 photos including the contest hashtag #myChristmasRecipe2014. Any kind of photos are accepted (except pornographic or offensive material), provided they are related to the topic "food of the Christmas holidays." Among all deliveries, Only-apartments and Eatwith.com will select the most original photo, which will be awarded.

Each participant can upload from 1 to 3 photos. If a user uploads more than 3 photos, he will be immediately disqualified and we will proceed to remove the photos from the contest.

The prize consists of a 2 (two) night stay for a maximum of 2 (two) people in Barcelona and a dinner with Eatwith.com (according to the conditions established by Eatwith.com).

The trip should be taken advantage of before May 31, 2015. It is a personal, nontransferable prize. The specific conditions of the apartment will be applied. Once the booking is made, it will not be possible to change the dates.

4. Promotion dates: The promotion starts on December 21, 2014 at 08:00 am and ends January 9th, 2015 at 12:00pm.

5. Winner: The winner will be the participant whose photo is voted by Only-apartments and Eatwith.com as the most original, under the condition that he/she obliged in the participation requirements mentioned in the previous sections of 'Participation', 'Dates', 'Promotion Details and Prize'.
