

## CONTEST RULES #MYONLYBEEEXPERIENCE

**1. Organization:** The company organizing this promotion is ONLY-APARTMENTS, SA, Av. Drassanes 6-8, pl 15, 08001 Barcelona, CIF: A64425986

**2. Participation:** contest entrants can participate via email by writing to the following address: [communication@only-apartments.com](mailto:communication@only-apartments.com). Only entrants of legal age that have stayed at an Only-apartments apartment during the course of 2015 are eligible to participate. Employees of [Only-apartments.com](http://Only-apartments.com) and their direct family members are not eligible to participate.

**3. Mechanics of the promotion and prizes:** to enter, travelers will have to send in a text describing their stay at the apartment and destination city. These themes are to be strictly followed for the text to be accepted. The text should be between 50 and 200 words long. Texts with derogatory or offensive content of any type will be rejected. Only-apartments reserves the right to refuse admission of texts to the contest.

Only-apartments will select the 5 most creative texts from among all entries, and publish them in the #MyOnlyBeExperience section of the blog, so other users can cast their vote.

**4. Dates:** the contest will be launched on 17/09/15, and participants will be able to send in their texts until 05/10/15. The voting period on the blog will begin on 06/10/15 and end on 20/10/15 at 11pm. The winner will be announced on 21/10/15.
